



Wellington Hockey Association Registration Terms and Conditions

By registering with Wellington Hockey Association (WHA), I confirm that I have read and agree to the following:

TERMS AND CONDITIONS

These terms and conditions (**Terms**) govern the provision of hockey related services by Wellington Hockey Association (**WHA, we, us**) to participants (**you, your**) in WHA facilitated, administered or managed hockey events, programs, and/or competitions (**WHA event**).

By participating in a WHA event and/or registering with WHA, participants agree to these terms of use (Terms).

By accepting these Terms you agree, as participant, and/or as parent/guardian acting on the participant's behalf:

- that you either are the participant, or that you have the participant's authority and consent to bind the participant to these terms and conditions;
- you have read and understood these terms and conditions of registration;
- that the details provided on the participant/user profile and relevant registration form(s), including profile information in PlayHQ, are to the best of your knowledge true and correct;
- you will, if requested by WHA, provide evidence of your (or your child/dependent(s), if applicable) age, or of any other information you provide.
- to pay the applicable registration fee to WHA by completing the online payment gateway information associated with any online registration with your affiliated club and/or WHA;
- that you (or the child/dependent you are registering on behalf of) may access copies of the current applicable Handbook, Regulations, By-Laws and Policies referred to above upon request to WHA;
- that you (or the child/dependent you are registering on behalf of) understand(s) and will comply with all applicable current handbook, WHA policies, codes of conduct and by-laws and consents to the jurisdiction of WHA tribunals;
- that any failure by you (or the child/dependent you are registering on behalf of) to adhere to the current applicable handbook, code of conduct, Regulations and Policies of , WHA), may result in you (or your dependent) being sanctioned or de-registered
- you acknowledge that we may amend these Terms at any time with or without notice to you and any such updated Terms will be available on our website.

Assumption of Risk

Hockey is a contact sport in which physical injury may occur from time to time and you assume the risks arising from participating in hockey and hockey-related activities.

Injury, Loss or Damage to Persons or Property



You undertake and agree that if you or your child/dependent cause injury, loss or damage to any other person or property in any way, you shall pay for that injury, loss or damage as required by law and you shall keep WHA and its agents indemnified against such injury, loss or damage unless such injury loss or damage was covered by an insurance policy held by WHA.

You agree that if you or your child/dependent are injured or suffer loss or damage to property, WHA and its agents shall not be responsible for such injury, loss or damage whether or not such injury, loss or damage was caused by WHA or its agents, by negligence or otherwise, unless such injury loss or damage was covered by an insurance policy held by WHA.

Cancellation, Refunds and Termination

Refunds of registration fees paid to WHA are at WHA's sole discretion. A pro rata refund may be made available to a participant who is prevented from participating from a majority of the registered event(s) as a result of developing a medical condition (*a doctor's certificate may be required*).

Approved refunds will be transferred back to participant / guardian minus applicable payment gateway transaction fees as required.

Subject to WHA's sole discretion, refunds are not available due to cancellations related to events outside of WHA's control, including but not limited to inclement weather, acts of god, government health regulations, participant cancellations, earthquake or natural disasters.

Use of Participant's Image or Likeness

You consent to WHA's or its affiliated partners' use of the participant's name, image, likeness as well as information related to their performance in any WHA sanctioned game, program or event for the purposes of content production and communication, and acknowledge that such use may involve the creation of content including but not limited to images, videos and live streaming. You acknowledge and agree that such content is owned by WHA and that WHA may use any images or videos for promotional or other purposes without payment or other consideration. Safeguarding Children and Young People
